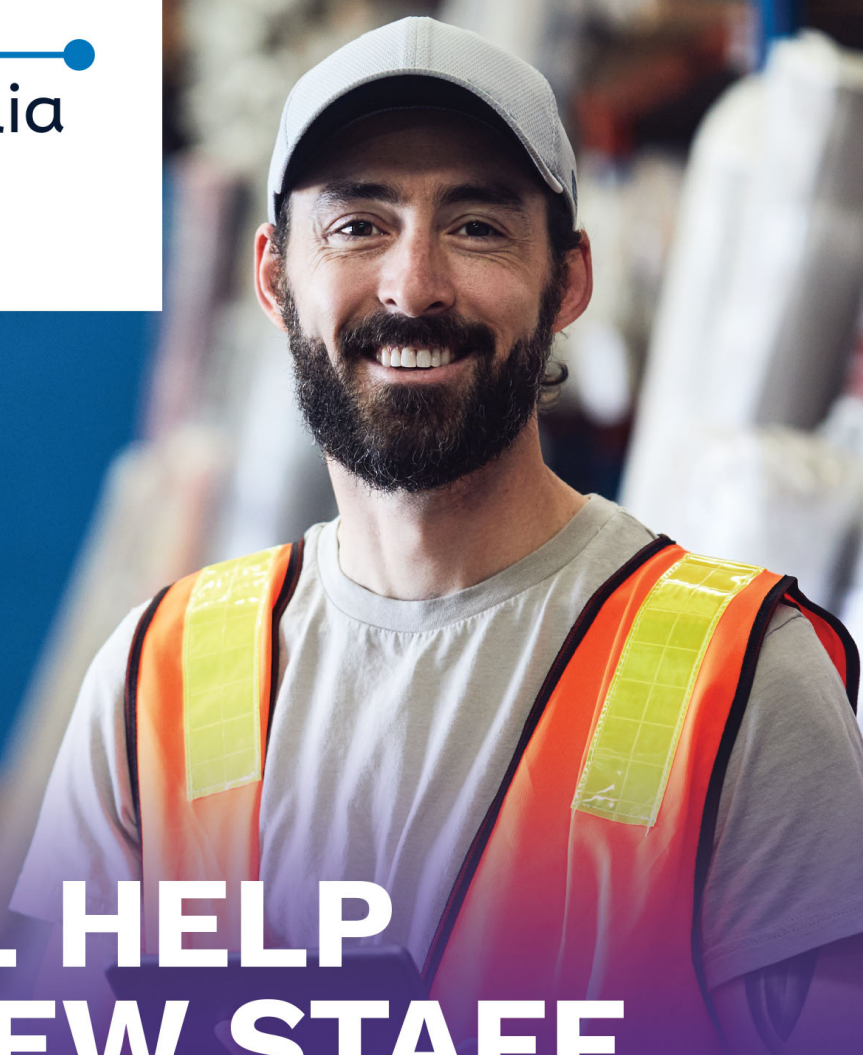

FINANCIAL HELP TO HIRE NEW STAFF

Build your business with
Australian Government wage subsidies.

Get up to \$10,000

Your business may be able to get up to \$10,000 (GST inclusive) when you hire new employees.

- Support a young person into work with the Youth Bonus Wage Subsidy:
 - Offer a minimum of 20hrs/wk for 26 weeks.
- Support an older job seeker into work with the Workforce Australia Services Wage Subsidy:
 - Offer a minimum average of 15hrs/wk for 6-26 weeks.

Apprenticeships and traineeships

Apprenticeship and traineeship placements are also eligible for a wage subsidy along with other financial incentives available to employers under the Australian Apprenticeships Incentives Program.

National Work Experience Programme

Employers who decide to hire an individual who has completed a National Work Experience Programme may also be eligible for a wage subsidy.

Jobfind can offer you a wage subsidy when you employ eligible job seekers from our services. Eligible businesses can receive payments over a maximum 26-week period. You can set the payment schedule to suit your needs.

Talk to your local Jobfind team about your eligibility:

- you must have an Australian Business Number
- you have not previously received a wage subsidy for the same person
- your business is not an Australian, state or territory government agency
- the person you hire meets the eligibility requirements for the wage subsidy
- the position you offer meets the minimum hours per week and employment period requirements
- the work complies with employment standards for the position (for example, is suitable work and pays as a minimum the national award wage).
